NARRATIVE

On 09-10-2014 at 1533 hours, I responded to for a harassment complaint. Upon my arrival, I met with the complainant, Sandhya Desmond, who stated the following:

Approximately ten years ago, Desmond was working at Yale New Haven Hospital when she fell. As a result of the fall, Desmond injured her wrists and had permanent nerve damage to her hands. Because of her injuries, Desmond has an ongoing lawsuit with Yale. For the last ten years, Desmond has had several Private Investigators following her.

Desmond stated she has gotten use to a P.I. being parked on her street. However recently, a P.I. has become very aggressive in following her and her family. Desmond stated there have been several incidents over the last month and a half, where the P.I.'s driving has put her and her family in harms way. Desmond requested that I make contact with the P.I. or his company and inform them of the above. Desmond then provided me with CT registration plate

I then responded back to Police H.Q. and made contact with the operator of the vehicle, Ryan Kaiser. Kaiser informed me that he has been a P.I. for eight years and has never broken any laws in the performance of his investigations. Kaiser then stated he would have his boss call me.

I then received a phone call from Brian Cyr. I informed Cyr of Desmond's concerns and he stated he would speak to Kaiser.
